Note for doctoral candidates who are planning a publication or an application for an extension of the publication deadline:

The following granting of rights to TU Darmstadt shall not apply if proof of publication in printed form is provided within the prescribed period and shall also not apply as long as the possibly extended period for publication pursuant to § 20 para. 2 or 3 has not yet expired.

However, if you do not meet the submission deadline/publication deadline, the following granting of rights will take effect. In this case, TU Darmstadt will publish the electronic copy of your approved dissertation deposited by you with the ULB on a server that is not accessible to the public until then via TUpriints in order to prevent the doctorate from failing (§ 20 para. 4 and 7 PO/AT).

In this respect, you must grant these rights as a precautionary measure when uploading the electronic version of your dissertation to the ULB server, which is not accessible to the public.
